Understanding the CARE Act

Learning more about the recently passed federal CARE Act, intended to help blunt the worst economic impacts of the pandemic on individuals, businesses and nonprofits, will be critical for many SCFD organizations. Fortunately, there are resources available to help you learn more, and in consultation with your advisers, make good decisions for now and for the future.

The CARE Act also makes important changes to encourage charitable giving including creating a new above-the-line deduction (universal or non-itemizer deduction that applies to all taxpayers) for total charitable contributions of up to \$300, eliminating the current 60 percent income cap on annual contributions for

those who itemize in 2020 and raising the annual limit from 10 percent to 15 percent for corporate donations.
