### WHAT YOU NEED TO KNOW

#### **SCFD GATHERING DATA FOR DECISIONS AFFECTING 2022**

We are in the process of collecting data and speaking with legislative & legal experts to determine options and solutions available to us for application year 2022. We will update you when we have more solid information.

#### **PROJECTED DISTRIBUTION AMOUNTS FOR 2021**

As we are using 2019 data for the 2021 distribution formula, we have those projections available now. Remember: these projections are based on the 2021 SCFD budget, you will receive actual funds collected. These projections are based on the assumption that ALL Tier II organizations submit successful reports by the June 18th deadline. **If an organization misses this required deadline, they will not be eligible for distributions during the 2021 cycle; therefore adjusting these projections.**
