#### PROJECT COMPLETION REMINDER

**2021 PROJECTS:** Earlier this year, SCFD extended the use of 2020 funds due to pandemic-related problems affecting the completion date. The extension deadline to use funds received in October 2020 is December 31, 2022.

**2022 PROJECTS:** Funds awarded in October 2021 must be spent by December 31, 2022.
