# 1. Introductions and Quorum Determination

Chair Ray Gonzales called the meeting to order at 1:02 p.m. A quorum was present. Each Board member introduced themselves.

# 2. Review & Approval of Agenda

Marcela de la Mar motioned to approve the agenda. Jamie Torres seconded. Motion to accept the agenda passed.

# 3. Oath of Office: Teresa Valerio Parrot, Boulder County

Chair Gonzales introduced Teresa Valerio Parrot, who then read the Oath of Office. She was welcomed onto the SCFD Board.

# 4. Approval of November 17, 2022 Board Meeting Minutes

Jamie Torres motioned to approve the November 17, 2022, Board Meeting Minutes. Jake Zambrano seconded. Motion to approve the November Board Meeting minutes passed.

# 5. Presentation: Elizabeth Garner, Colorado State Demographer

Elizabeth Garner from the Colorado Department of Local Affairs presented population and migration trends on statewide, regional and county levels. She also presented implications based on the trends as well as a long-term forecast.

# 6. Reports 6.1 Treasurer

In Suzanne Crawford's absence, Marcela de la Mar reported the December 2022 SCFD sales and use tax revenue was \$8,073,128.61. This brings the total Fiscal Year (FY) 2022 sales and use tax revenue to \$85,755,983.39. This compares to FY 2021 sales and use tax revenue of \$76,394,351.23. The variance is \$9,361,632.16, a 12.25% increase in FY 2022 over FY 2021.

#### 6.2 Chairman

Chair Gonzales began his report by thanking and recognizing Gino Greco for his service as immediate past Board Chair and leading SCFD through much of the pandemic. Although Gino was not present for the meeting, he was praised by fellow Board members and staff for his guidance and navigation to virtual meetings. He was also assigned a guitar performance at a future Board event.

Chair Gonzales also recognized Deborah Malden who attended the meeting to "pass the baton" to Teresa Valerio Parrot. Deborah expressed enthusiastic support for Teresa's addition to the Board. Deborah also pledged continued support of SCFD and the arts, culture and science community. Many Board members and public attendees thanked and lauded Deborah for her many years of service.

Chair Gonzales continued his report announcing the creation of ad-hoc committees to support SCFD Day at the Capitol (April 13, 2023), Summer party (June 15, 2023) and Holiday event (December 14, 2023). He asked the Board for volunteers who would be willing to work with staff on these events, to let him, Marcela or Deborah Jordy know by March 1, 2023.

To conclude his report, Chair Gonzales reminded the Board to submit meeting RSVPs to Arlene. A quorum is required at each meeting to conduct District business.

### **6.3 Executive Director**

Deborah Jordy began her report by thanking Elizabeth Garner for providing valuable information that impacts our District, each county and all SCFD funded organizations.

She continued with updates from the SCFD office:

- On February 21<sup>st</sup>, a training was conducted for County Cultural Council members on "Deciphering Nonprofit Financials". Almost 40 people attended, and Deborah Malden provided a wealth of knowledge.
- The Final Grant Report deadline for 2022 funds was February 8<sup>th</sup>. Unfortunately, 13 grantees missed the deadline, rendering them ineligible to apply in the 2023 grant cycle.

• The Tier III application deadlines for single and multi-county grants are coming up in March. The Program Officers will be very busy processing hundreds of applications.

Executive Director Jordy gave the floor to Program Officer, Dana Manyothane who provided a summary of 2022 Eligibility. Organizations had a September 14, 2022 deadline to apply for eligibility. SCFD received 24 complete applications in 2022. This compares to eight complete applications received in 2021. Of the 24 applicant organizations, 11 were deemed eligible to apply for funding in 2023. The county breakdowns for the newly eligible organizations are:

- Adams = 1
- Arapahoe =1
- Boulder = 6
- Broomfield = 0
- Denver = 2
- Douglas = 0
- Jefferson=1

Deborah Jordy concluded her report with a reminder that SCFD has a table at the upcoming 2023 Colorado Business Committee for the Arts (CBCA) Awards Luncheon on March 7<sup>th</sup>. Three open seats remain for interested Board members who have not already committed to attend.

Jake Zambrano reported that the EDIA sub-committee included himself, Jacki Cooper Melmed, former SCFD Board members Kathy Kucsan and Carlos Martinez, Dana Manyothane and Deborah Jordy. Together with The Equity Project consultant group, the sub-committee created a draft EDI statement included in the Board member meeting packet. Chair Gonzales called for a vote. Jacki Cooper Melmed motioned to approve the Equity, Diversity, and Inclusivity Statement as presented. Marcela de la Mar seconded. The motion passed.

## 4. Reports

#### 4.1 Treasurer

Suzanne Crawford reported the February 2023 SCFD sales and use tax revenue was \$6,280,381.03 The 2023 year-to-date (YTD) sales and use tax revenue is \$12,471,184.81 in comparison to YTD 2022 sales and use tax revenue of \$11,687,583.16. The variance is \$783,601.65, a 6.70% increase in YTD 2023 over YTD 2022.

#### 4.2 Chairman

Vice-Chair Marcela de la Mar presented the Chair report starting with a welcome to SCFD's new Communications Manager, Emma Mantooth. Emma is completing her second week at SCFD. She joins us from the El Pomar Foundation. Emma holds degrees in Spanish and Communication Arts and is an accomplished violinist. Welcome Emma, to the SCFD family.

Next, Marcela provided an update on Deborah Jordy's health. After a successful surgery, Deborah is resting comfortably at home. To conclude her report, Vice-chair de la Mar reminded everyone that the May 25<sup>th</sup> Board meeting will be in-person at the Denver Art Museum. Each Tier I organization will present an update and a quorum is needed to conduct district business. Please ensure May 25<sup>th</sup> at 1:00 pm is on everyone's calendar.

#### **4.3 Executive Director**

Deputy Director Jessica Kato presented the report for Deborah Jordy.

# 4.3.1 Update to Bylaws

Jessica directed the Board to the redlined copy of the Bylaws included in their Board packet. Updates were made to keep SCFD Bylaws in line with statutory language. The gift policy has been changed to align with the State's gift policy. There is now a \$75 limit to the value of any individual gift received by a Board or staff member of SCFD. This includes complimentary tickets.

Suzanne Crawford motioned to approve the updated Bylaws. Gino Greco seconded. Motion to approve the SCFD updated Bylaws passed.

Jessica continued her report with updates from the office:

- SCFD's 2023 Day at the Capitol occurred on April 12<sup>th</sup>. This successful event included the Colorado Korean Chorus singing the national anthem in the House gallery. Swallow Hill Music and Butterfly Pavilion also provided interactive entertainment. Our mascot was in attendance and caught the attention of 9News, including a moment on Kyle Clark's "Next" program.
  - Signed SCFD tributes will be distributed to the Board at the May meeting. Deputy Director Kato thanked Jack Finlaw and Teresa Valerio Parrot for attending Day at the Capitol.
- Tier III update since the beginning of March, the Program Officers have processed and analyzed 254 grant applications and attended 20+ study sessions with county Cultural Councils to review the applications.
- Tier II update an annual submission training was held on April 26<sup>th</sup> with 50+ people in attendance. The Tier II deadline is June 14<sup>th</sup>.

- The Tier I annual submission deadline was April 26<sup>th</sup>. Board members will receive information on how to access Tier I submissions for review prior to the May Board meeting.
- SCFD lobbyist Fofi Mendez is monitoring several bills in the legislature including one that exempts sales tax from those rebuilding after a fire. SCFD revenue will experience a slight drop with the passage of the bill.
- With Kendal Zimmermann's shift to a remote, contract position, SCFD is accepting Program Officer applications through April 28<sup>th</sup>.
   Over 50 applications have been received. The new Program Officer is expected to start in mid-June.

Upon conclusion of Jessica's report, many Board members acknowledged Kendal's tenure at SCFD and expressed thanks for her assistance and dedication.

# 4. Reports

#### 4.1 Treasurer

Suzanne Crawford reported the March 2023 SCFD sales and use tax revenue was \$7,445,034.06 The 2023 year-to-date (YTD) sales and use tax revenue is \$19,916,218.87. This compares to the YTD 2022 sales and use tax revenue of \$18,762,988.89. The variance is \$1,153,229.98, a 6.15% increase in YTD 2023 over YTD 2022.

#### 5.2 Chairman

Secretary Zambrano presented the Chairman's report. He began by recognizing Jack Finlaw upon his departure from the SCFD Board. Jack

was a member of the SCFD Board for five years and served in the role of Chair for two years. Fellow board members and SCFD staff also thanked Jack, who then spoke briefly and highlighted the accomplishments of the Tier I leaders and their organizations.

Secretary Zambrano also welcomed Executive Director Jordy back from her medical leave.

#### **5.3 Executive Director**

Deborah Jordy began by thanking the cultural community for their support. She then continued with updates in the following areas:

- SCFD's 2023 Day at the Capitol occurred on April 12<sup>th</sup> and signed copies of the SCFD tribute read in the House of Representatives are available for each Board member.
- Each Board member is asked to sign the annual Disclosure Statement confirming the review of SCFD Bylaws, procedures, and Code of Ethics. Please submit the signed document to Arlene.
- The summer party scheduled for June 15<sup>th</sup> has been cancelled. There will be a reception for the Board, staff, Tier II organizations, and meeting attendees after the August Board meeting at the Arvada Center.
- The 2023 legislative session is now complete. SCFD lobbyist Fofi Mendez tracked approximately 17 bills, none of which had a major financial impact on SCFD. Deborah offered an opportunity for Fofi to present a legislative recap and forecast at an upcoming Board meeting.
- Staff updates: Kendal Zimmermann transitions to her Grants
   Management System Consultant position in July. Christine Fiedler
   will join the SCFD staff as Program Officer on June 13<sup>th</sup>. Christine has
   over a decade of experience in philanthropy and fundraising and
   most recently served as Development Director with the Colorado
   Cross-Disability Coalition. She is familiar with SCFD from her time at
   the Foothills Art Center.
- The 2022 audit is wrapping up. The results will be presented at the July Board meeting. Deborah thanked Deputy Director Jessica Kato and SCFD Accountant Gloria Nedved for their contributions to a clean audit.
- With Tier I certification reports complete, SCFD Program Officers are wrapping up Tier III application reviews. Tier II grantees are reminded that their annual submission deadline is June 14<sup>th</sup>.
- The metro area is seeing a number of leadership changes: Mayoral election, City Council and Commissioner turnover in various counties, a new Director at Colorado Creative Industries, etc.

Deborah will work with newly elected officials to ensure their understanding of SCFD's value to our community.

Chair Gonzales called the meeting to order at 1:04 pm followed by introductions. A quorum was present.

#### 2. Welcome from Vintage Theatre

Vintage Theatre Executive Director Margaret Norwood welcomed everyone to the black box Bond-Trimble space and explained that the building previously belonged to Shadow Theatre Company. The building contains three performance spaces, including a small cabaret stage in the lobby. The main auditorium is named after Shadow Theatre's founder, Jeffrey Nickelson and his daughter, ShaShauna Staton, is Vintage's current Board President.

Margaret shared Vintage's commitment to provide performance space to other community organizations in need of a venue. Other programs include a summer youth camp and elementary school touring productions that extend into Douglas and Adams counties. Vintage's next main stage production, "Cabaret", will open on September 15<sup>th</sup> and Margaret hopes it will sell out like their recent plays and musicals. Margaret concluded her welcome by expressing profound gratitude for SCFD funds that allow Vintage Theatre to expand their programs and reach.

Councilwoman Jamie Torres motioned to approve the agenda. Jacki Cooper Melmed seconded. Motion to approve the meeting agenda passed unanimously.

# 4. Oath of Office, Raymond H. Gonzales, Governor Appointee

Chair Ray Gonzales read the Oath of Office as a recent Denver County resident and Governor Appointee. He will fulfill the remainder of Jack Finlaw's term, ending in May 2024.

### 5. Approval of May 25, 2023 Board Meeting Minutes

Chair Gonzales motioned to approve the May 25, Board Meeting Minutes. Suzanne Crawford seconded. Motion to approve the May Board Meeting minutes passed unanimously.

### 6. Reports

#### **6.1 Treasurer**

Suzanne Crawford reported the May 2023 SCFD sales and use tax revenue was \$7,234,892.95. The 2023 year-to-date (YTD) sales and use tax revenue is \$33,962,387.99. This compares to the YTD 2022 sales and use tax revenue of \$33,087,367.23. The variance is \$875,020.76, a 2.64% increase in YTD 2023 over YTD 2022.

#### 6.2 Chairman

Chair Gonzales announced that the August Board meeting will be held at the Arvada Center for the Arts and Humanities. One-third of the Tier II organizations will present updates and the meeting will be followed by a networking happy hour.

An economic impact of the arts fun fact: Taylor Swift's recent sold-out concerts in Denver contributed over \$100 million to our local economy. SCFD staff members Emma Mantooth and Christine Fiedler attended. We look forward to the upcoming sales and use tax revenue report from July to see how SCFD funds are impacted.

Chair Gonzales concluded his report with a moment of silence in support of Executive Director Deborah Jordy's ongoing health challenges.

#### **6.3 Executive Director**

In Deborah Jordy's absence, Deputy Director Jessica Kato provided the following updates:

- Welcome to the new Program Officer, Christine Fiedler, who started on June 13.
- Program Officers have completed reviews and analyses of all 33 Tier II organizations. In the next few weeks, Board members will receive instructions on accessing the Tier II summaries. Eleven Tier II grantees will present at the August Board meeting.
- The Engage, Empower, and Connect (EEC) Summit co-hosted by Denver Botanic Gardens and the Collaborative of the SCFD will be held on Tuesday, September 19, at the Denver Botanic Gardens. This year's event will include breakout sessions on Workplace Wellness; Equity, Diversity, Inclusivity, and Access; Development in a Changing World and Issues Communication. A keynote panel will also consist of local cultural legends

moderated by Westword Editor Patty Calhoun. EEC will conclude with a networking reception.

Thank you to Emma Mantooth for spearheading the organization of the event.

 SCFD's 2024 budget is being finalized by Jessica Kato and Gloria Nedved. It will be discussed with Treasurer Suzanne Crawford prior to being presented to the Board in September.

# 7. Fiscal Year 2022 Audit and Resolution

# 7.1 Report by SCFD Auditor John-Paul LeChevallier, CPA, CliftonLarsonAllen LLP

CliftonLarsonAllen issued an unmodified, "clean" audit opinion for SCFD. This is the highest level an organization can achieve.

Significant items from the 2022 Audit include:

- Implementation of GASB Statement No. 87, Leases
  - SCFD's office space lease moves to a capital asset and long-term liability of \$405,900
- General Fund (short-term) increase in ending fund balance from \$523k in 2021 to \$2.2m in 2022
- Governmental Activities (long-term) increase in net position from \$738k in 2021 to \$1.8m in 2022
- Net Pension Asset \$52k, participation in Colorado PERA
  - Improvement of \$224k from 2021. This is an informative disclosure required by government accounting standards and not under SCFD control.
- Tier Distributions totaling \$84,469,644 (\$75.2 million in 2021)

To clarify for the Board, SCFD Accountant Gloria Nedved shared that monthly financials show only operating and distributions. The lease information and net pension asset items are only found on the Audit. John-Paul confirmed this is common practice as neither item impacts what needs to be spent by SCFD.

The audit found no adjustments or misstatements and was filed with the State of Colorado on time. John-Paul offered kudos to SCFD for a clean and smooth audit with no issues.

# 7.2 Resolution 23-05: Pertaining to Acceptance and Approval of Fiscal Year 2022 Audit

After reading Resolution 23-05: Pertaining to Acceptance and Approval of Fiscal Year 2022 Audit, Jacki Cooper Melmed motioned to approve the resolution. Vice-Chair Marcela de la Mar seconded. Motion to accept and approve the 2022 audit passed unanimously.

## 8. Arts Advocacy Update; Meredith Badler, CBCA

Colorado Business Committee for the Arts Deputy Director, Meredith Badler presented an update on arts advocacy for metro Denver and Colorado. CBCA tracks and influences legislative activity on both a state and national level. They convene

the Colorado Legislative Arts Caucus and advocate for Colorado Committee for the Arts to improve our state's 46th-place ranking for arts funding per capita (\$0.35 per person). In January 2022, CBCA created the Colorado Arts Action Network allowing residents to stay informed and easily contact their legislators to voice support for the arts. Going forward, CBCA is creating a statewide arts advocacy platform to guide future policy priorities and issues and is seeking community feedback: <a href="https://www.surveymonkey.com/r/artsadvocacyco">https://www.surveymonkey.com/r/artsadvocacyco</a>

The next CBCA Economic Activity Study will be presented on Thursday, November 2, from 9:30 am – 11:00 am at Denver Art Museum. All members of the community are invited. Please save the date. Official registration will begin in August/September.

Upon conclusion of the CBCA presentation, Councilwoman Jamie Torres asked what information was available regarding Governor Polis's veto of the Fix the Tix bill. Meredith stated that ticket resellers have a very vocal and powerful lobby that may have influenced the veto decision. Raymond Gonzales shared that the Governor issues a veto summary which may provide insight on his rationale.

Councilwoman Torres also asked about the priority level of property tax and real estate impact on art institutions. Meredith replied that the link for community feedback provided above allows respondents to rank their highest priorities and allows for write-in topics. CBCA will move forward on the most popular issues.

Jannett Matusiak asked if the Fix the Tix bill campaign is ongoing. CBCA is waiting for the latest Senate committee developments to determine the next steps. It will likely be an ongoing campaign.

### 5. Reports

### 5.1 Treasurer

Suzanne Crawford reported the June 2023 SCFD sales and use tax revenue was \$7,571,391.48. The 2023 year-to-date (YTD) sales and use tax revenue is \$41,533,779.47. This compares to the YTD 2022 sales and use tax revenue of \$40,714,788.67. The variance is \$818,990.80, a 2.01% increase in YTD 2023 over YTD 2022.

#### 5.2 Chairman

Vice-Chair Marcela de la Mar presented the Chairman's report on behalf of Ray Gonzales. She announced that the September Board meeting will be held at the Northglenn Arts & Humanities' new Parsons Theatre. Members of the seven county cultural councils will be presenting their Tier III funding priorities, process and plans for the 2023 grant cycle.

This year's event will include breakout sessions on Workplace Wellness; Inclusivity, Diversity, Equity and Access; Development in Changing Times and Issues Communication. All the breakout sessions are currently full. #### 4.1 Treasurer

In Suzanne Crawford's absence, Secretary Jake Zambrano reported the July 2023 SCFD sales and use tax revenue was \$7,406,422.56. The 2023 year-to-date (YTD) sales and use tax revenue is \$48,940,202.03. This compares to the YTD 2022 sales and use tax revenue of \$48,007,623.05. The variance is \$932,578.98, a 1.94% increase in YTD 2023 over YTD 2022.

#### 4.2 Chairman

Chairman Ray Gonzales began his report announcing that Governor Appointee Courtney Ozaki resigned from the Board. She has accepted a staff position with the Denver Center for the Performing Arts that would present a conflict of interest. We wish her well in her new role. Deputy Director Kato met with the Governor's office to discuss a new appointee for Courtney's Board seat; Chair Gonzales and Vice-Chair de la Mar will be discussing appointee options with Executive Director Jordy in preparation for the end of their terms in May 2024.

Adams County has appointed Commissioner Eva Henry as their representative to the SCFD board. She will be taking her Oath of Office at the October Board meeting. Secretary Zambrano and Vice-Chair de la Mar will serve as the nominating committee for the 2024 slate of officers. Any Board member interested in serving in a leadership capacity is invited to contact them. They will present a slate at the October meeting and it, along with any nominations from the floor, will be voted on at the November meeting.

To conclude his report, Chair Gonzales expressed his joy at Executive Director Jordy's return and welcomed her back.

#### **4.3 Executive Director**

Deborah Jordy began her report with gratitude for all the well wishes and support she received during her absence. She is currently working part-time hours and plans to return to full-time at a later date.

Deborah recognized Communications Manager, Emma Mantooth for her seamless execution of the Engage, Empower and Connect (EEC) Summit held on September 19<sup>th</sup> and co-hosted by Denver Botanic Gardens and the Collaborative of the SCFD. Emma provided an event recap and highlighted the following:

- The ~200 registrants represented all SCFD Tiers, County Cultural Council members and the public.
- In addition to breakout sessions, participants attended a "Local Legends" keynote panel moderated by Westword Editor Patty Calhoun. On the panel were local artist and 2022 SCFD Rex Morgan Civic Engagement and Volunteerism award recipient, Darrell Anderson; Mudra Dance Studio founder, Namita Khanna Nariani and Su Teatro Executive Artistic Director, Tony Garcia.

Executive Director Jordy continued with the following updates:

- Colorado Business Committee for the Arts' (CBCA) 2023 Economic Activity Study (EAS) roll-out event is November 2<sup>nd</sup> at the Denver Art Museum. Datapoints from the EAS will be valuable to understand how the arts sector is recovering since the pandemic. The event is open to the public and the registration link was posted in the meeting chat.

2024 budget highlights include:

- A conservative sales and use tax projection of \$85 million. This is a 2% decrease over the estimated 2023 year-end collections and roughly equal to the actual revenue collected in 2022.
- Proposed 14% increase in expenditures over 2023 (fully staffed, increased benefits, investing in partnerships, public awareness, website accessibility, & software protection)

Gino Greco asked if the increased expenses are a result of program growth and expected to be sustained going forward. Deputy Director Kato indicated that is correct.

A surplus of \$506,667 is projected in FY 2024. SCFD leadership will meet with the Board to discuss strategic use of this amount. The six-month emergency reserve is fully funded and the Election Cost Reserve is intact (\$1.3 million currently).

Executive Director Jordy thanked Jessica Kato and SCFD Accountant Gloria Nedved for their detailed preparation of the 2024 budget.

Suzanne Crawford reported the September 2023 SCFD sales and use tax revenue was \$7,563,832.27. The 2023 year-to-date (YTD) sales and use tax revenue is \$64,106,599.85. This compares to the YTD 2022 sales and use tax revenue of \$63,242,753.37. The variance is \$863,846.48, a 1.37% increase in YTD 2023 over YTD 2022.

#### 4.2 Chairman

Chair Gonzales thanked his fellow officers for their service throughout 2023 and Executive Director Jordy echoed his gratitude.

#### **4.3 Executive Director**

Deborah Jordy's report included the following updates:

- Legislator meetings continue with the help of Lobbyist Fofi Mendez. Six more meetings are scheduled before year-end. Deborah will continue to provide SCFD introductions and updates in preparation for the 2024 Legislative Session.
- When the 2024 legislative session begins, SCFD's weekly email "Wednesday Wonders" will return. These messages feature short videos of our funded organizations, in addition to quick facts about the impact of arts, culture and science in the metro area.
- Please save the date for SCFD's Day at the Capitol on Wed. February 21, 2024. Additional details will be provided as they are finalized. This is a wonderful opportunity to interact with legislators and help them understand all that SCFD grantees provide in each of their communities.
- Communications Manager, Emma Mantooth has been working closely with website consultant, Ligature Creative, to ensure that our website, www.SCFD.org, complies with current accessibility standards.
- Please submit RSVPs for this year's holiday event at the Denver Zoo on Wed. December 6<sup>th</sup> at 5:30 p.m. We will have a reserved area where hors d'oeuvres and warm beverages will be served before you venture out to see the lights. We look forward to celebrating the holiday season with your families.
- The volunteer Cultural Councils in each county make decisions for Tier III grant funding, and those councils typically have a few vacant positions each year. Board members are asked to provide names of interested candidates to the SCFD office. The staff will pass along candidate names to the appropriate counties.

On November 2<sup>nd</sup>, Teresa Valerio Parrot attended the Colorado Business Committee for the Arts's (CBCA) Economic Activity Study roll-out event. Teresa appreciated the introductions facilitated by Deborah and seeing SCFD's impact throughout the district. Teresa also recognized Deputy Director, Jessica Kato and Program Officer, Tim Murphy for their work to provide the underlying data for the report.

# 5. Colorado Creative Industries (CCI) Welcome & Update: Josh Blanchard, Executive Director

Josh explained that CCI is part of Colorado's Office of Economic Development and International Trade (OEDIT), and he started his position in September 2023. CCI is in the early stages of a strategic plan to evaluate its 17 current programs, explore new programs and expand their impact throughout Colorado. He is looking forward to

collaborating with SCFD about how rural Colorado communities can secure ongoing funding for creative nonprofits in their community.

# 6. Diversity in the Arts (DITA) Internship Update: Rachel Basye, Executive Director, Art Students League of Denver

Rachel began her presentation by thanking SCFD for supporting DITA, which is celebrating its fifth anniversary. DITA's mission is to cultivate future arts leaders from communities of color and other underrepresented populations. The 2023 cohort had nine interns at nine host sites for a 10-week, full-time, paid internship. Host organizations are granted funds to offset intern compensation.

Rachel highlighted the significant effect the internship has had on participants' careers, with some interns being permanently hired by their host organization and some joining the DITA Advisory Board. To date, the program has 44 alumni as well as 24 host organizations in four metro counties (Denver, Boulder, Jefferson, Arapahoe). Rachel invited SCFD Board members from Adams, Broomfield and Douglas counties to connect her with potential host sites in their area to expand DITA's reach.

Rachel shared DITA's program calendar for 2024. Intern applications will be open on January 2<sup>nd</sup> and information will be provided to SCFD for wide distribution.

Deborah Jordy pointed out that SCFD's financial support of DITA comes from interest income and not taxpayer dollars. Rachel further explained that although host organizations must have a nonprofit status, they are not required to be an SCFD grant recipient. However, SCFD dollars are only given to host sites within Tier I, II or III.
